4. **Low Slope Roofs:**
 - a. **Contractor is to provide GAF Liberty SBS self-adhering cap sheet over Liberty SBS Self-adhering or mechanically attached base sheet per manufacturers recommendations (or equal).**
 - b. **Contractor to provide a 20yr system warranty.**
 - c. **Color to be selected by owner from full range of standard colors.**
