Addendum Number 1 is issued to provide changes and/or clarifications to the above referenced Bid as per the following:

Questions:

1. Will the City kill the grass growing in the cracks prior to the successful bidder's award?
No, the city will not do any advance weed or grass control.
2. Can a separate bid item be added to address the re-striping that will be required?
There will be no re-striping required by the contractor.
3. Is the crack between the asphalt and concrete curb and gutter part of this Scope of Work, previous crack sealing project in the City have this joint sealed.
The joint between the asphalt and concrete curb and gutter is not part of the scope of this project.
4. Cracks with existing sealant do not need to be routed, just blown out and re-sealed, correct?
Yes, if the crack has previously been sealed then the contractor can blow out and re-seal. These areas will need to be approved by the City inspector.
5. What are the allowable working hours?
The work can begin at 6:00 am. Night work can be requested by the Contractor. The City will evaluate the request based upon location and vicinity to residences.

All other provisions of the Contract Documents shall remain unchanged. This addendum is hereby made part of the Contract Documents to the same extent as though contained in the original documents and itemized listings, thereof.

Each bidder is required to acknowledge receipt of each addendum in Section 3 of the Bid Proposal, failure to do so could render the bid non-responsive.

1. Sign-in sheet and introductions
2. Project scope: Crack sealing city streets, traffic control, and nightly clean-up. Base bid work (5 streets). 5 Bid alternates identified.
3. Schedule: 80 calendar days to Substantial Completion for Base Bid work plus 30 days to Final Completion (Section 8, Page 2). Additional calendar days per bid alternate (if Awarded).
4. BID OPENING is Tuesday October 16, 2018 at 11 am. Bidder questions must be submitted by 4:00 pm October 4. Questions received after that time will not be answered. Bidder questions must be directed to Purchasing either via fax at 575.439.4117 or via email to bpYeatt@ci.alamogordo.nm.us. Questions submitted will be answered by written addendum and will be binding.
5. Ten percent (10%) bid preference for local bidders is applicable for this project (See Section 2, Article 30.0). Section 2, Articles 33.0 and 34.0 cover In-State Preference and Resident Veterans Preference. Resident Veterans Preference Certification is in Section 7. A Bidder must specify which preference they would claim if qualifying for more than one. The preference values are not cumulative.
6. Section 2, Article 17.0 lists documents that must be submitted with the bid package.
7. Project will be awarded based upon base bid. Bid alternates may be awarded at the city's option, all or none, or any combination. Award of bid alternates will be based upon project budget.
8. For Reclaimed Water Rates contact the Water Billing Department at 575.439.4288. Locations of Reclaimed Water Hydrants are listed in Article 01-002.1 (3.0), page 6.
9. Wage Rates apply. Certified payrolls will be required and can be submitted vial email.
