The following information and attachments will amend, modify, and/or clarify the bid documents described above and are hereby part of the same. Please incorporate these items into the bidding documents for the above referenced project. Please acknowledge receipt of this on the bid form.

1. Section 1.8 Bid Schedule: Project #1 Hilton Head Island.
 - a. Change approximate total length from 1.76 miles to 3.17 miles.
 - b. Revised bid schedule is included with this addendum.
2. Section 1.8 Bid Schedule: Projects #1, #2 and #4 – Allowances for leveling and full depth patch (FDP).
 - a. Leveling allowance (10% of total HMA tons) and FDP allowance (5% of total resurfacing area SY) shall be shown on the separate line items provided on the bid schedule. **DO NOT** include these costs in the Total resurfacing cost for project #1, #2 and #4.
3. Project Summary – page 5: Contract Time.
 - a. Change Project #1 from 30 to 60 calendar days.
 - b. Project days are cumulative. If awarded two or more projects the project days will be added together.
4. Bid Proposal page 1 of 3. Start and completion of work.
 - a. Change Project #1 from 30 to 60 days.
 - b. Project days are cumulative. If awarded two or more projects the project days will be added together.
5. Project Summary (page 4) Clarifications item #5 permitted work hours.
 - a. McCracken Circle – Contractor shall coordinate their work with Beaufort County School district to minimize disruption to school operations. Unless Beaufort County Schools permits otherwise, work shall be permitted between 9 pm and 6 am.
