PROJECT DESCRIPTION: The project consists of furnishing all labor, materials, services, and equipment for fabrication, delivery, and erection of all items of work related to the addition to and renovation of the existing Indoor Sports Complex. The building addition shall consist of 13,346 s.f. to provide space for a new gymnasium with storage and expansion of a lobby space. The building systems for the addition will be constructed with reinforced-concrete slabs-on-grade with reinforced-concrete strip wall footings. The building superstructures will consist of masonry bearing walls with steel roof trusses, joists, & steel roof deck with CMU shear walls. The exterior enclosure systems will include manufactured stone veneer, metal wall panels with CMU and fiberglass-impregnated gypsum sheathing/metal-stud back-up. The exterior enclosure systems will also include fixed, glazed aluminum storefront systems. Portions of the building will also include non-load bearing CMU wall construction. The roofing systems shall consist of fully-adhered, EPDM roof systems on tapered insulation sloped to interior roof drains and standing-seam metal roof systems. The Scope of Work includes installation of heating, ventilation, air conditioning, plumbing, fire protection, fire alarm, and electrical systems, and installation of storm sewer utility service extensions and rough-in/coordination for telephone and CATV utility services. The Scope of Work shall include sitework, concrete and asphalt paving, PVC-coated chain link fencing and stormwater systems. In addition, the project shall include site development, interior construction, reinforced-concrete pads and coordination/hook-up of/connection to owner-furnished/vendor-installed equipment. Elements of the site development shall also include parking lot saw-cut and patching w/re-striping as required and concrete curb saw-cut and patching. The Scope of Work shall also include a pre-engineered, pre-finished metal sunshade to match the existing sunshade on the existing building.

TYPE OF PROJECT: This project is for general construction with a lump-sum bid.

BID SECURITY: Bid security in the form of a Bid Bond by the Bidder and a Surety Company licensed to do business in the State of Tennessee equal to five percent (5%) of the bid will be required. No bidder may withdraw his bid within 30 days after the actual date of the opening thereof. Bid security will be returned to all bidders upon award of the Contract for Construction or rejection of bids.

GUARANTY BOND: A Guaranty Bond in the form of a Performance/Labor and Material Bond in an amount equal to one hundred percent (100%) of the bid contract sum will be required, and the cost shall be included in the bid.

TENNESSEE CONTRACTOR'S LICENSE LAW: Bidding shall be in accordance with the Tennessee General Contractor's License Law. Bidders on construction in the amount of \$25,000.00 or more must be a licensed contractor as required by the Contractor's Licensing Act of 1976, Public Chapter #82 of the General Assembly of the State of Tennessee amended by Public Chapter #406, Public Acts 1977, and further amended by House Bill #2507 and approved May 10, 1994.

BIDDING ENVELOPE REQUIREMENTS: On the face of the bidding envelope, the bidder shall present the following information:

- The Project Name
- The Bidder's Name, Address, License Number, and License Date of Expiration

- The Date and Time of the Bid Opening
- The Name, Address, License Number (if applicable), and License Date of Expiration for each subcontractor.

Without this information on the face of the envelope, the bid will not be opened by the Architect.

DRUG-FREE WORKPLACE AFFIDAVIT: Bidding shall be in accordance with the Tennessee Code Annotated 50-9-113. All bidders **must** submit a completed Drug-Free Workplace Affidavit with his/her bid. Any bid not accompanied by a signed and notarized Drug-Free Workplace Affidavit will not be accepted. A copy of the Drug-Free Workplace Affidavit is attached to the bid form.

ETHICAL STANDARDS AFFIDAVIT: Bidding shall be in accordance with the Tennessee Code Annotated 50-9-113. All bidders **must** submit a completed Ethical Standards Affidavit with his/her bid. Any bid not accompanied by a signed and notarized Ethical Standards Affidavit will not be accepted. A copy of the Ethical standards Affidavit is included in the Project Manual (Document 00403 – Ethical Standards Affidavit).

BUSINESS TAX AND LICENSE AFFIDAVIT: Bidding shall be in accordance with the Tennessee Code Annotated 50-9-113. All bidders **must** submit a completed Business Tax and License Affidavit with his/her bid. Any bid not accompanied by a signed and notarized Business Tax and License Affidavit will not be accepted. A copy of the Business Tax and License Affidavit is in the Project Manual (Document 00404 – Business Tax and License Affidavit).

CERTIFICATION OF COMPLIANCE WITH THE IRAN DIVESTMENT ACT: Bidding shall be in accordance with the Tennessee Code Annotated 12-12-101. All bidders **must** submit a completed Certification of Compliance with the Iran Divestment Act with his/her bid. Any bid not accompanied by a signed and notarized Certification of Compliance with the Iran Divestment Act will not be accepted.
