IN THE MATTER OF AWARDING BID FOR APPROVED VENDORS FOR EQUIPMENT RENTAL FOR VARIOUS DEPARTMENTS OF FRANKLIN COUNTY

WHEREAS, certain departments of Franklin County from time-to-time have the need to rent various types of equipment to efficiently and effectively perform their duties; and

WHEREAS, publication dates of solicitation for bids for equipment rental were October 24th, October 31st, and November 7th, 2018, for the 2019 fiscal year; and

WHEREAS, the Purchasing Department received a response from four (4) vendors from the solicitation, namely, Luby Equipment Service, GW VanKeppel Co., Cummings, McGowan & West, and Fabick Cat; and

WHEREAS, due to the nature of equipment needs, none of the vendors would be equipped to be the sole provider to supply all of the equipment needed and the Purchasing Department recommends all vendors should be awarded; and

WHEREAS, in addition, the Purchasing Department further recommends four (4) employees be authorized to execute lease agreements on behalf of Franklin County: Mike Davis, Bill Carroll, Darren Walker, Tony Henry and Ron Williams.

IT IS THEREBY ORDERED the bid for equipment rental is awarded to all four (4) vendors: Luby Equipment Service, GW VanKeppel Co., Cummings, McGowan & West, and Fabick Cat to satisfy the equipment needs of Franklin County.

IT IS FURTHER ORDERED that the above named personnel are authorized to execute equipment rental agreements with Luby Equipment Service, GW VanKeppel Co., Cummings, McGowan & West, and Fabick Cat.

IT IS FURTHER ORDERED, that the bid awards recommended by the Purchasing Department are hereby accepted and approved and the Presiding Commissioner is authorized to execute any and all necessary documents on behalf of the County of Franklin and such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Order, for and on behalf of and as the act and deed of the County.

IT IS FURTHER ORDERED, that the County shall, and the officials, agents and employees of the County are hereby authorized and directed to, take such further action, and execute and deliver such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Order.
