#### TO ALL POTENTIAL BIDDERS:

The following information is being provided for purposes of clarification or in response to questions received from potential contractors. <u>In the event that any of these specifications conflict with previous specifications</u>, the specifications in this addendum shall control. Prepare your quotes accordingly:

- 1. Deadline for quotes has been extended to Thursday, December 9, 2021 at 2 p.m.
- 2. A new Quote Form is attached. Please use the new one when submitting your quote.
- 3. Work hours shall be Monday Friday, 7 am 5 p.m.
- 4. County staff are in the building 24/7 and work shall be phased to provide the least disruption to normal operations.
- 5. All VCT Tile shall remain and new vinyl plank flooring will be installed over the VCT.
- 6. Revisions to Section A, Scope of Work, are noted in red below.
  - 1. Rooms 101 & 104 (Offices)
    - i. Remove and replace approximately 1 foot of sheetrock
    - ii. Remove existing carpet and padding and install new
    - iii. Remove cove base and Install new cove base
    - iv. Paint walls and trim
  - 2. Rooms 105 (Radio Room)
    - i. Replace VCT Title with Install vinyl plank flooring
    - ii. Remove cove base and install new
    - iii. Paint walls and trim
    - iv. Optional item: Replace laminate countertop
  - 3. Rooms 100, 106, 107 & 119 (Front Entry and Hallways)
    - i. Replace VCT Tile with Install vinyl plank flooring
    - ii. Remove and replace approximately 1 foot of sheetrock
    - iii. Remove cove base, as needed, and install new

- iv. Paint walls and trim
- 4. Rooms 102 & 103 (Training Room and Storage Closet)
  - i. Remove and replace approximately 1 foot of sheetrock
  - ii. Remove cove base and Install new cove base
  - iii. Replace VCT Tile with Install vinyl plank flooring
  - iv. Paint walls and trim
  - v. Paint doors
- 5. Rooms 108 & 109 (Restrooms)
  - i. Replace VCT Title with Install vinyl plank flooring. Partition supports shall be raised, and toilets removed/replaced to allow for a seamless installation. Floor drain may also need to be raised.
  - ii. Remove cove base and replace with new
  - iii. Paint walls and trim
- 6. Rooms 122 & 123 (Shower Rooms)
  - i. Remove shower curtain rods, shelves, towel racks, mirror and sink from the walls.
  - ii. Remove and replace floor and wall tile.
  - iii. Remove and replace plumbing fixtures shower faucets.
  - iv. Install new Go Green Board floor to ceiling.
  - v. Install waterproofing and antifracture membrane on floors and walls.
  - vi. Install a Schluter 16" x 20" niche in each shower.
  - vii. Install new 5/8" marble thresholds.
  - viii.Install new handicapped bars in shower area.
  - ix. Install new shower curtain rods.
  - x. Room 123 Only: Install a sink similar to the one in Room 122.
  - xi. Room 122 Only: Reinstall sink and mirror.
- 7. Rooms 110, 111 & 113 (Kitchen, Pantry & Dayroom)
  - i. Replace VCT Tile with Install vinyl plank flooring
  - ii. Remove existing carpet and padding and replace with new
  - iii. Remove cove base and replace with new.
  - iv. Replace kitchen countertop with new laminate countertop (existing cabinets to remain).
  - v. Replace countertop at the service window with a new laminate (same as kitchen).
  - vi. Paint walls and trim.
  - vii. Paint both sides of service window doors.
- 8. Rooms 114 & 115 (Bunk Rooms)
  - i. Remove existing carpet and padding and replace with new
  - ii. Remove cove base and replace with new
  - iii. Paint walls and trim
- 9. Room 118 (Decon Room)
  - i. Install wall tile half way up wall, except by floor sink where it will go to the ceiling. Details to be provided at pre-bid meeting.
  - ii. Paint walls, trim and inside of door.
  - iii. Install wall tile from floor to ceiling by the floor sink.
  - iv. Install wall tile, as a 12" backsplash, behind countertop.
- 10. Exterior Doors (Door 100, 107, 122, 113)
  - i. Paint the interior of all exterior doors the same color as trim.
- 11. Room 124 (Storage Closet)
  - i. Install vinyl plank flooring
  - ii. Paint walls and trim
- 7. Revisions to Section B, Materials, are listed below.
  - Item 3, Vinyl Plank Flooring shall be in Dark Oak color.
  - Cove Base in kitchen along cabinets shall be black.

- Laminate countertops shall be Nevamar, Rush, FS6001T.
- Shower Room Floor and Wall Grout shall be waterproof MAPEI Karapoxy CQ.
- Shower Faucets shall include a sprayer.
