Addendum Number 1 is issued to provide changes and/or clarifications to the above referenced PWB as follows:

**Clarification:**

1. Prospective bidders are advised that UPS and FEDEX cannot guarantee delivery by 2:00 p.m.
2. Painting shall consist of one (1) coat of primer and two (2) coats of paint. All finishes shall be semi-gloss. Elastomeric paint shall be applied to EIFS surfaces and applicable paint type shall be applied to all other exterior surfaces; i.e., hollow metal doors/frames, columns, downspouts, etc.
3. Contractor will be allowed to work on weekends if requested.
4. Contractor shall anticipate 2 colors to be selected for the EIFS surfaces, and a third color selection for other surfaces such as hollow metal doors/frames, columns, downspouts, etc.

All other provisions of the Contract Documents shall remain unchanged. This addendum is hereby made part of the Contract Documents. Each bidder shall acknowledge receipt of this Addendum Number One (1) using this acknowledgement page and submit with the Bid proposal.

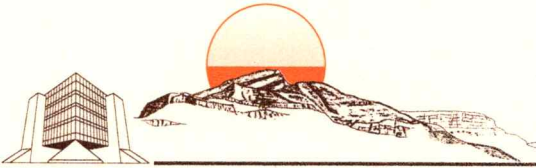
