This clarification is being provided to all known and registered correspondents in response to questions received. Question #1: On the forms, it indicates that Olive Park is to be cut on a monthly schedule and is 19 acres. Is this the proper maintenance schedule? For a location that size we would recommend that it be maintained weekly.

Response: **The 19 acres monthly is for an unimproved area for potential future project construction – it is not part of park/field complex. Olive Park monthly 19 acres remains as is.**

Question #2: The packet mentions that no spraying or the use of chemicals will be allowed. Does this apply to the fence lines and concrete cracks such as sidewalks and or parking lot cracks?

Response: **County staff handles chemical application.**

REVISION: Please note an error in the original solicitation. The Andrews Recreation Center, 209 S. Maple, Andrews shall be changed from 16 acres/weekly to 9.5 acres/weekly. Please bid accordingly and note this change on your mandatory bid submittal form so that we can verify you have quoted correctly.
