Addendum 01 May 9, 2022 IFB 22-B0038 Hotel Demolition and Asbestos Abatement

The purpose of this Addendum 01 to IFB 22-B0038 for Hotel Demolition and Asbestos Abatement, dated April 27, 2022, is to list the key points of discussion from the mandatory site visit.

- Contractor is to leave intact as much asphalt/concrete as possible to help keep dirt in place. To that end, the dirt level should be a little lower than the asphalt.
- Contractor is responsible to dispose of all contents from the hotels, including all furniture.
- Silt fence may be installed after demolition. The City will arrange for perimeter fencing.
- All four (4) structures currently have no power. It will be the Contractor's responsibility to ensure that gas and sewer is properly disconnected.
- Contractor will be responsible for DHEC permits and inspections.
- Contractor licenses for this project (ex: asbestos abatement, general contractor, etc.) must be in accordance with South Carolina state law.
- On the flash drive, there is a folder entitled "Bid Forms to be Submitted." This folder contains the following documents that **MUST** be submitted as part of the bid package:
 - o 002218 Bidder's Representation
 - o 002219 Non-Collusion Affidavit
 - o 002220 License Statement
 - o 002221 Experience Statement
 - o 002222 Project Superintendence
 - o 004113 Bid Form (all sections, including 1.5 and 1.8)
 - o Both price schedules
 - o Bid bond/power of attorney

Failure to submit any of the documents above <u>WILL BE</u> just cause to have a bid considered non-responsive. Any bid package that does not contain all documents listed above <u>WILL NOT</u> be read aloud.

• Award will be based on the total price for all four (4) buildings. Award will be made on an "all or none" basis. No partial bids for single buildings allowed. Contractors are cautioned to be realistic on their unit price form for possible additional work. The City reserves the right to negotiate any and/or all prices listed on the unit price form.

- Additional questions are due no later than 12:00noon on Friday, May 13, 2022. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com All questions received by the deadline will be answered via addendum.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Thursday, May 19, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
