- 2. Can we directional drill across 58<sup>th</sup> Ave? No, Contractor is to use an open-cut method.
- 3. Is there a Geotechnical Report available? Not as of this date. It will be published as an addendum once available.
- 4. What is the groundwater depth? This information will be provided in the geotechnical report.
- 5. Do Davis Bacon wages apply? Yes
- 6. Are electrical plans for the lift stations available? There are no electrical plans for the lift stations.
- 7. Is there an Engineers' Estimate available for this project? Estimate is \$1,174,312.14
- 8. In regards to item #7 Can 8" DR11 type HDPE pipe be considered an acceptable substitute for the currently specified C900 DR 18 Certa-Lok pipe? No, the close tolerance bore needs to be C900 DR-18 Certa-Lok pipe.

In reference to the IRC ROW permit application #2022010981:

Indian River County (IRC) has underground fiber optic cable and other fiber infrastructure in the area referenced by the IRC ROW permit application. Please see the attached map which displays the approximate position of IRC fiber optic cable and other fiber infrastructure.

Please note that fiber optic cable shown on this map is meant to be a general representation of the approximate location of the infrastructure existing on the ground. The data should be treated as such; steps should be taken to ground truth the information to avoid damages. The data may also have gross inaccuracies and in many areas is largely incomplete.

The contractor/sub-contractor will need to call in Locates or call in a locate ticket so that the exact position of the IRC underground fiber optic cables can be located & marked onsite. The contractor should realize that the fiber optic cables may be present within conduit or directly buried; that information is not currently available to County GIS staff. The contractor must take appropriate measures not to destroy any buried infrastructure, whether it exists within conduit or not. The depth of any such underground fiber is unknown.
