<b>6</b>	<b>In addition to academic assessments, would KCKPS be interested in administering web based Social-Emotional Learning assessments?</b>
<b>KCKPS</b>	No.
<b>7</b>	<b>In addition to academic assessments, would KCKPS be interested in administering School Climate assessments?</b>

<b>8</b>	<b>In addition to assessment platforms, would KCKPS be interested in platforms that integrate and report student data in order to create and track interventions for MTSS?</b>
