- 1. Any building components, such as cabinets, sinks, toilets, furnace, water heaters, will need to be removed prior to abatement in order to access all asbestos containing materials. It will be the responsibility of the abatement contractor to remove these components place materials in a roll-of-container or truck and haul it to the proper landfill for disposal. The Abatement Contractor will be responsible for disposal and the cost associated with the removal of all components.
- 2. The abatement contractor must furnish all original waste manifest to the city with their Invoices to be paid for the disposal.
- 3. In reference to the survey report provided by Apex Environmental Management and dated June 14<sup>th</sup>, 2017, there are no buildings 1-6.

# The following changes and or clarifications listed below will apply.

- 1. There is no power and water on the site you will need to furnish it.
- 2. Building #30 the Administrative building is not included in the removal.
- 3. Building #8 the fire damaged building will not be included in the work
- 4. The contractor will have 70 days total to complete the contracted work.
- 5. The bid bonds apply as stated at 5%.
- On the second floors there are two layers of plywood and asbestos tile that will be removed.
- 7. There is some asbestos tile under some of the bathroom ceramic tile, refer to the reports.
- 8. APEX will be making a correction in the report regarding the plywood.
- 9. The bid opening will be moved to August 15, 2017 not August 8, 2017
