After reviewing the Federal Regulations from 2 CFR Part 200, and staff discussions we unfortunately cannot allow the bids to be selected the way they were submitted to us. Selection of all the lowest bids must be made in order to be in compliance with the Federal Regulations. The significant price difference of \$7,050 is too great to consider timeliness to be advantageous. Another factor in this, is due to you all projecting this project to be over budget and requiring more funds to complete the 68 approved Cammie units; we need to keep costs as low as possible. Below are the excerpts we are using to make this determination:

Section 200.320 Methods of procurement to be followed.

“Procurement by sealed bids (formal advertising). Bids are publicly solicited and a firm fixed price contract (lump sum or unit price) is awarded to the responsible bidder whose bid, conforming with all the material terms and conditions of the invitation for bids, is the lowest in price...” (c)

“The procurement lends itself to a firm fixed price contract and the selection of the successful bidder can be made principally on the basis of price”(iii)

“A firm fixed price contract award will be made in writing to the lowest responsive and responsible bidder. Where specified in bidding documents, factors such as discounts, transportation cost, and life cycle costs must be considered in determining which bid is lowest.” (iv) The following vendors submitted responses to the above solicitation:
