QUESTIONS AND ANSWERS

- 1. I understand that BCSD plans to purchase the Barracuda service annually over a period of five years. The bidding schedule, however, looks like it includes a single line for the full dollar amount for all five years in total. Barracuda has indicated that there will be nominal price increases in the later years, so can we modify the bidding schedule on our response reflect that?
 - BCSD cannot pay for a multiyear license up front. The license will have to be paid annually per our procurement code.
