1) QUESTION: I am in PA and will not be in GA during your uniform times. Does that disqualify me?

<u>ANSWER:</u> If a representative cannot be available in person during uniform ordering ttimes, the bid will not be considered complete.

2) QUESTION: Page 14, item 5 states "ADDITIONAL UNIFORMS – ADD ONS OR REPLACEMENT UNIFORMS THREE (3) TO FIVE (5) DAYS" - it takes 2-3 days just to get jerseys from the manufacturers. You give 2-3 weeks to receive the initial order but less than 5 days for fill ins? Please advise.

<u>ANSWER:</u> Add ons or replacements should be no more than 7 days at the most. The County prefers 5 days.

- 3) QUESTION: Are we able to quote on alternate styles than the 3 brands shown for each sport? ANSWER: Yes, the blanks on the quote sheet are for alternate brands.
- 4) QUESTION: Do you have a Quantity for the Soccer Portion? ANSWER: 250 for soccer in house.
- 5) <u>QUESTION:</u> Will you be accepting substitutes? We manufacture or own Athletic Apparel and I would like to know if we can bid this?

ANSWER: Yes, the blanks on the quote sheet are for alternate brands.

6) <u>QUESTION:</u> Can we make note of a package price on the bid form aside from the alla carte pricing?

<u>ANSWER:</u> To ensure a fair comparison across all bids, the County can only accept prices as requested on the bid sheet.
