Question #3:

Can we use 3" post for terminals instead of 4"? The 4" is overkill. We've used 3" on all the other facilities.

Question #4: Can we use 4' fence for the separation fence instead of 5'? Again, that is

what is on the other facilities.

Response: Yes.

Question #5: Does the sport court at S. Island get lights? If so, what's the layout?

Response: We did not specify a layout, will depend upon what lighting is used. Is to

be recreational level lighting.
