Response: There are 3 courts that have reached the end of usable lifespan. We want

to replace with 2 tennis courts and 1 basketball/sport court (instead of 3

tennis courts).

Question #2: Site A: If this is not a demo, do we need to remove and reinstall new net

posts?

Response: New net posts.

Question #3: Site A: Is the fencing and lighting staying in place or does it need to be

replaced with new fencing and lighting?

Response: New fencing & lighting.

Question #4: Site A: Would we be able to request a more in depth scope of work for

this site?

Response: There is no additional information.

Question #5: Site B: What is the preferred construction access to the tennis court?

Response: We will work with contractor on appropriate access.

Question #6: Site C: There are three proposed sites, which will be the actual site?

Response: Courts to be constructed adjacent to existing courts - To be situated on

site in general area of existing courts in a manner that does not require move of playground. Will work with contractor to accomplish this.

Question #7: Site C: Will the playset and manhole need to be removed? Who will re-

setup the playground if it needs to be moved?

Response: See response to question #6. Situate on site so that nothing needs to be

moved.

Question #8: Site C: Will Georgetown County be responsible for relocating utilities?

Response: The County does not expect any utilities to be relocated for this project.
