- 1. Please replace pages 24 through page 33 with the attached updated information:
 - Shelving Color Code Reference Guide
 - Detailed Specification Sheets
 - Color coded diagram of both the existing library as well as the new Children's Library
 - Updated Exhibit "A" Fee Schedule
- 2. For clarification, the Parkland Library project is divided into two phases. The phases are:
 - i. Renovation of the existing library building.
 - ii. Construction of a 7,000 square foot addition to the existing building.
- 3. Please see the new detailed specification sheets for all shelving which are included with this addendum.
- 4. For purposes of this bid, laminates for end panels and tops are to be delivered as follows:
 - Existing main library-Panolam Township Maple
 - Children's library-Nevamar Siren Maple

Vendors may offer an equal which is subject to City approval. Should the City decide to change the laminate color which could result in an upcharge, the City of Parkland will work with successful bidder on cost revisions to the costs included in the bid.

- 5. Bidders should use the attached updated "Exhibit A, Fee Bid" for the bid submittal. In addition, pricing for freight, delivery and labor and installation are separate line items but to be included in the total bid cost.
- 6. Bidders should include samples of the metal and laminate finishes they are proposing. Bidders should state if the samples are to be returned after the award of bid is finalized.

Questions/Clarifications and Answers:

The following question(s) (shown in italicized text) were submitted by prospective proposer(s). The City's responses are presented here (shown in bold text). The submitters' names and email addresses have been removed due to privacy requirements.

- 1. Specifications call for "Summit" as the finish color for metal shelving, but they also say finishes are subject to final approval. Will the finish color be chosen from the successful bidder's standard finish options or should the bid include an upcharge for a custom finish to match "Summit"?
 - For purposes of this bid, all metal components of the shelving will be delivered in Autumn White Model 1210. This is a standard color Aurora Storage. Bidders may offer an equal which is subject to City approval.
- 2. For #1, the model number identified, S3-36112266-S, references (10) 11" deep (nominal) shelves, which is 10" deep actual shelves. The specifications call for (8) shelves "depth is 10"". Please clarify quantity of shelves and the nominal and actual depth of shelves.
 - Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.
- 3. For #2, the model number identified, S3-36112266-A, references (10) 11" deep (nominal) shelves, which is 10" deep actual shelves. The specifications call for (8) shelves "depth is 11"". Please clarify quantity of shelves and the nominal and actual depth of shelves.
 - Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.
- 4. For #3, the specifications call for tops of "varied lengths (144", 180", 108", 72" tops)", please provide a layout drawing so tops can be configured and quantified and/or provide quantities of each length.

 - Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.
- 6. For #4, the model number identified, S3-36111166-S, references a shelving unit with an 12-1/2" deep (nominal) shelving unit, which is 11-1/2" deep actual. The specifications call for a shelving unit with the size "37-1/4" W, 11-1/2" D, 66" H". Please confirm the depth of the shelving unit.

- 10. For #7, it does not reference a model number and describes the shelving as custom with "4-shelf (3 shelves with 4 openings)". Please clarify the number of shelves. Is it 4 shelves or 3 shelves?

 Also, please provide additional specifications on what is meant by a "inset magazine shelf."
 - Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.
- 11. For #7, the specifications call for "High pressure laminate Nevamar Regency Mahogany W8352-VE, continuous top shelf with square edge". Are end panels and canopy tops required for

this product? If so, please provide a drawing and/or specify quantity of end panels, and the quantity and length of each top needed.

For purposes of this bid, laminates for end panels and tops are to be delivered as follows:

13. For #9, the quantity states "2" and "custom", but it is unclear what is being specified. It appears to be (2) Double Face shelving units sized 37" W, 24" D, 42" H with concealed casters, but there is not a shelving unit model number provided. OR is it only (2) hang-up racks equal to model number S3-BAG3612. Therefore, please clarify what the quantity is referring to and provide specifications for this product.

Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.

14. For #9, if this product is for shelving units, please provide specifications for the shelving units. Is it for two starters? Or One starter and one adder? Or something other than starter and adder?

15. For #9, if this product is for shelving units, please provide the quantity of hanging bag rods/racks needed and the nominal and actual depth of shelving units.

Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.

16. For #9, a "High pressure laminate top- laminate- Nevamar Siren Maple WM0005-T, continuous double face top shelf with square edge" is specified. Please identify what the High Pressure laminate is for on this item, as there are no end panels or tops listed.

- 20. It appears that #10, which are starters, and #11, which are add-on units, are paired for a total of 32 units of shelving. However, there is not a specification for end panels or tops identified for these 32 units of shelving. If products #10 and #11 require end panels and tops, please provide a drawing and/or specify quantity of end panels, and the quantity and length of each top needed.
 - Please see the attached color coded diagram of the shelving requirements as well as the specification sheets for both phases of the project included with this addendum.

- 21. For #12, the model number identified, S3-36112242-S, references (6) 11" deep (nominal) shelves, which is 10" deep actual shelves. The specifications call for (4) shelves per unit where "shelf depth is 10"". Please clarify quantity of shelves and the nominal and actual depth of shelves.

- 22. For #13, the model number identified, S3-36112242-A, references (6) 11" deep (nominal) shelves, which is 10" deep actual shelves. The specifications call for (8) shelves per unit where "shelf depth is 11"". Please clarify quantity of shelves and the nominal and actual depth of shelves.

- 23. Related to #14, #15, #16, and #17:
 - a. Given that #14 and #15 appear to be paired **and** #16 and #17 appear to be paired;
 - b. And that #14 calls for (2) single face start units (model S3036111166-S) and #14 calls for (8) single face adder units (model S3-36111166-A) **and** #16 calls for (2) single face start units (model S3036111166-S) and #17 calls for (8) single face adder units (model S3-36111166-A);
 - c. (#14 and #15) **and** (#16 and #17) appear to be duplicates;
 - d. If it the above are duplicates, please identify what to omit.

If an additional item for end panels and tops for the second set of shelving units are needed, please provide a drawing and/or specify quantity of end panels, and the quantity and length of each top needed, plus the finish.

30. For #18, the specifications call for tops of "varied lengths (216", 72" tops)", please provide a

layout drawing so tops can be configured and quantified and/or provide quantities of each length.

- 31. Assuming #19 and #20 are paired, #19, which is for (1) single face starter unit 66" high (model S3-36111166-S), and #20, which is for (8) single face adder units 60" high (model S3-36111160-A), the two products have different heights. Please provide the correct model number and height for #19 and #20.

The specifications call for a shelving unit with the size "36" W, 10" D, 60" H". Please confirm the depth of the shelving unit.

- 36. For #20, **assuming the 60" is an error** and it should be 66", please identify the correct model; provide the quantity of shelves; provide the nominal and actual depth of shelves and provide the nominal depth of the shelving unit.

- 37. For #21, the specifications call for a quantity of (9). It appears #21 is meant to go with #19 and #20, in which case, the quantity is not correct. Please confirm the correct quantity of end panels and quantity of tops.






