

RESOLUTION NO. 2019-045

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, TO AWARD THE LOWEST, RESPONSIVE AND RESPONSIBLE BIDDER, THE LIBRARY INTERIORS OF FLORIDA, INC., FOR LIBRARY SHELVING FOR PARKLAND LIBRARY, ITB 2019-09, IN THE AMOUNT OF \$96,157; PROVIDING FOR EXECUTION BY THE APPROPRIATE CITY OFFICIAL; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Parkland (City) requires the services of a qualified firm to provide and install library shelving for the Parkland Library; and

WHEREAS, on March 15, 2019, in accordance with the City's Procurement Code, City staff issued Invitation to Bid (ITB) No. 2019-09 for Library Shelving for Parkland Library; and

WHEREAS, on April 9, 2019, the City opened the ITB and four (4) bids were received with no declination; and

WHEREAS, staff and City's consultant have reviewed the lowest bid and after careful evaluation is recommending the award to the lowest, responsive and responsible bidder, The Library Interiors of Florida, Inc., in the amount of \$96,157.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:

Section 1. The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporated herein.

Section 2. The Library Interiors of Florida, Inc. is hereby awarded ITB 2019-09 for Library Shelving for Parkland Library, in the amount of \$96,157.

Section 3. The appropriate City Official is authorized to execute the agreement.

Section 4. The ITB packet has been reviewed and approved by the City Attorney.
