

Town of Medley ITB 2019-014 Emergency Repair Sanitary Sewer Project Project No. WS-0142 Addendum # 1

The Town held the non-mandatory, pre-bid meeting on 10/01/19 @ 10:00 AM at 10776 NW South River Drive, Medley, FL 33178, see the attached sign in sheet for the participants. The meeting started approximately on 10:20 AM and ended on 10:45 AM. The project is under the cone of silence and all other questions related to this RFP can only be addressed through bidinfo@townofmedley.com.

At the meeting the project scope of work and the schedule of events were explained as detailed on pages one (1) and five (5) of the Invitation to Bid for the Construction of the Emergency Repair Sanitary Sewer Project, Project No. WS-0142. Finally, the bid form – pages nine (9) through eleven (11) of 23 were read in its entirety. At the meeting several questions were asked, see the answers below.

TOWN RESPONSE TO CONTRACTOR QUESTIONS:

- 1. **Town Clarification (TC):** Item No. 1 includes the mobilization & demobilization of all work for each of the line items included in the work to be performed under this contract.
 - <u>During the pre-bid meeting it was incorrectly stated that the MOT was not included in the unit price.</u> The MOT for each line item **must be included in the unit price of each item.**
- 2. **Town Clarification (TC)**: The Town clarified that Town Hall only works Monday through Thursday. The Town Utility Department works Monday through Friday.
- 3. **Town Clarification (TC)**: The Town strongly recommends that the bidders review all construction documents included in the ITB 2019-014 prior to final bid submittal.
- 4. **Applicant Question (AQ)**: Please clarify if "top hat liner" is the same as "t liner"?
 - **Town Response (TR)**: Yes. The liner that the Town is looking to place is from the sewer main line up into the sewer lateral.

5. **Applicant Question (AQ)**: For Item # 4 of the bid form, will the elevation of the pipe be provided?

Town Response (TR): The Town has provided the rim and invert elevations for each of the manholes on the Sewer Repairs Sketches for the contractor to determine the approximate elevation of the pipe at point of excavation.

6. **Applicant Question (AQ)**: In addition to Bid Bond requirements of paragraph #9 as shown on page 4 of 23 of the bid form, there was no bid bond form in the package.

Town Response (TR): The form is included with this addendum in accordance with paragraph 9 of the document. Attachment #1

7. Applicant Question (AQ): Does the Town have an engineer's estimate?

Town Response (TR): Yes, the engineer's estimate is included with this addendum. Attachment #2

8. **Applicant Question (AQ)**: Are there any liquidated damages due to the time sensitivity of this contract?

Town Response (TR): Yes, there are liquidated damages in addition to paragraph nine (9), in this contract and the language will be included with this addendum. Attachment #3

9. **Applicant Question (AQ)**: Will there be any dates under moratorium, or non-working days since the contract will be let close to the holiday's? If so, will those days be added to the contract? Will the Town be shutting down any specific dates?

Town Response (TR): The contractor will be required to submit a work schedule and the holiday's will need be included in the schedule. The Town will be closing on the following dates:

- Thanksgiving day full day off and the following day full day off.
- Christmas Day full day off and the following day full day off.
- New Year's Day full day off.

No additional days will be added to the days of the contract due to the holidays.

10. **Applicant Question (AQ)**: Will pre-CCTV and post-CCTV need to be included in the unit prices?

Town Response (TR): Yes, pre-CCTV and post-CCTV are to be included in the unit prices in accordance with the construction documents.

11. **Applicant Question (AQ)**: Will the Town require a warranty for the services and materials provided.

Town Response (TR): Yes, all materials and services shall carry a one (1) year warranty from the date of final completion of the contract.

12. Applicant Question (AQ): Please provide an estimate or budget for this project.

Town Response (TR): Please see reply to question #5.

13. **Applicant Question (AQ)**: Do you happen to have an estimated project value and start date for the above noted project yet? Also, is there a bid list (or planholders list) available yet?

Town Response (TR): Please see reply to question #5. The contract start date will begin upon the issuance of the Notice to Proceed to the successful awarded bidder. All pertinent dates were provided in the schedule of events, page 5 of the Invitation to Bid. The planholders list, as of the date of this addendum, is attached. Attachment #4.

14. **Applicant Question (AQ)**: Can you please send us the most recent bid tabulation and unit price breakdown with similar work.

Town Response (TR): The Town has the engineer's estimate, please see reply to question #5.

15. Applicant Question (AQ): Please advise if a bid bond/surety are required for this project.

Town Response (TR): Please see reply to guestion #4.

16. **Applicant Question (AQ)**: To qualify a Lateral Connection Repair as an or "Equal", what is the procedure? Attached is our submission of proposed equal, which exceeds or meets the required product.

Town Response (TR): The bids will be evaluated for best value based on price and qualitative components of the lowest responsive and responsible bidder. The "or equal" products submitted by the awarded successful bidder will be evaluated upon award of the contract.

17. **Applicant Question (AQ)**: Is it possible to change the word "or" to "and" between ASTM F2561 and ASTM F1216 as ASTM F2561 has ASTM F1216 design appendix X1 process in its standard already to make sure that the City is getting a properly designed lateral lining system?

Town Response (TR): Upon evaluating both standards, the wording of the STANDARD SPECIFICATIONS SEWER MAINS AND LATERAL REHABILITATION BY LINING, will remain as provided in the construction documents.

18. **Applicant Question (AQ)**: Is it the City's intent to meet the ASTM 2561 Standard for lateral lining to have an engineered gasket in order to have a designed sealed system for its lateral conforming to ASTM 3240 Standard gaskets that are within the ASTM 2561 Standard?

Town Response (TR): The intent of the Town is to meet the requirements of the construction documents.

CONTRACT TIME AND DAMAGES

CONTRACT TIME

1. COMMENCEMENT

- 1.1 The Date of Commencement of the Work is the date established in the Notice to Proceed.
 - 1.2 Time of Substantial Completion:
 - A. The date of Substantial Completion of the Work or designated portion thereof is the date certified by the Town when construction is sufficiently complete, in accordance with the Contract Documents, so the Town can occupy or utilize the Work or designated portion thereof for the purposes for which it is intended.

2. CHANGE OF CONTRACT TIME

- 2.1 All time limits stated in the Contract Documents are of the essence of the Contract. NO CLAIM FOR DAMAGES OR ANY CLAIM OTHER THAN FOR AN EXTENSION OF TIME SHALL BE MADE OR ASSERTED AGAINST THE TOWN BY REASON OF ANY DELAYS.
- 2.2 No recovery for early completion. If the Contractor submits a schedule or expresses an intention to complete the Work earlier than any required milestone or completion date, the Town shall not be liable to the Contractor for any costs incurred because of delay or hindrance should the Contractor be unable to complete the Work before such milestone or completion date.
- 2.3 The Contract Time may only be changed by a Change Order or a written Amendment. Any claim for extension of time shall be made in writing to the Town not more than three (3) days after the detection or beginning of the occurrence of the event giving rise to the delay and stating the general nature of the claim; otherwise, it shall be waived. In the case of a continuing delay only one (1) claim is necessary. Contractor shall provide an estimate of the probable effect of such delay on the progress of the Work.

3. LIQUIDATED DAMAGES

Upon failure of Contractor to complete the Work within the time specified for Final Completion, (plus approved extensions if any) Contractor shall pay to the Town the sum of Three Hundred Dollars (\$300.00) for each day that the Substantial Completion of the Work is delayed beyond the time specified in the Contract for Substantial Completion, as fixed and agreed liquidated damages and not as a penalty. After Substantial Completion, if Contractor neglects, fails or refuses to complete the remainder of the Work within the Contract Time or any approved extension thereof, Contractor shall pay to the Town the sum of Three Hundred Dollars (\$300.00) for each calendar day (plus approved extensions if any) after the time specified in the Contract for Final Completion and readiness for final payment as fixed and agreed liquidated damages and not as a penalty. Regardless of whether or not a single Contract is involved, the above-stated liquidated damages shall apply separately to each portion of the Work for which a time of completion is given.
