This addendum is issued to answer questions received as of 4/5/21 for this work and shall be considered as part of the contract subject to all of the general conditions thereof, the same as if attached to and included in the original specifications. All items included in the addendum shall be covered in the Bid as submitted by the Contractor.

- Will the user need the ability to send content to each screen individually? **Yes, it does.**
- Most video walls connect through a "tiled" mosaic with DVI (signal) and RS232 (control) loop through from one panel to another to allow for a single input to the wall. This would eliminate the need for a video wall processor. Most decent media software platforms offer the ability to split the screen up for multiple content windows. There just isn't really a need for a video wall processor sending 9 individual HDMI signals in this application. Can the processor be omitted if the wall operates the same or better without it? **The processor can be omitted if works as vendor describes.**
- Is there an existing control system that will be used for the wall (Crestron, Extron, AMX, etc). **No Control System exists.**

- Can you give an explanation of what type of content will be used, and what the wall will be used for? **Want to stream live events from gymnasium to outside wall for viewing.**
- Does the wall that the video wall will be mounted to already exist? If so, what material is the wall composed of? Ideally, the wall should be blocked with 3/4" plywood, and drywalled to create as flat of a surface as possible. **The existing wall is block where screens will be mounted.**

Also, clarification on size of screen to equal the 165" it should be 9ea 55" not 49" monitors. Replace Cost Analysis sheet with enclosed.
