NOTES FROM THE PRE-BID MEETING

A Pre-Bid Meeting was held at the UTC Softball Fieldhouse, 301 N. Holtzclaw Ave., Chattanooga, TN 37404, on Tuesday, August 27, 2019 at 10:00. A sign-in sheet from the meeting is attached.

The existing conditions of the roof were observed from interior of the building, since the existing roof deck is considered to be unsafe to randomly walk on. Items that were pointed out and/or discussed are listed below, as are any decisions reached.

Item 1. Question about decking

- **Q 1:** Is replacement decking to be of like material to existing?
- A 1: Not necessarily. Contractor is requested to match existing decking thickness using least expensive decking material and cover possible that will qualify for required warranty from roofing manufacturer.

Item 2. Question about cleanup

- **Q 2:** Is the contractor responsible for cleanup of roofing material that falls into the interior of the building?
- A 2: Yes, but we will request that the softball team have as much material as possible removed from the space to facilitate the placement of plastic, etc. on the floor to facilitate cleanup. The hanging netting is expected to be removed from the space.

Item 3: Question about tying off personnel.

- **Q 3.** Is tying off for personnel a requirement.
- A 3. Job safety is the responsibility of the contractor. It is the contractor's responsibility to maintain and perform all tasks in a safe manner. Although the City cannot dictate the means and methods used to accomplish this, it has been highly suggested by those roofers that we've discussed the project with that tying off, or equivalent measure, be used to maintain workers safety until the actual condition of the roof and decking is determined.
- It was pointed out that the roofing contractor is not responsible for leaks determined to be from the window system adjacent to the barrel section of the roof. We are aware that there are issues with the window closures on those windows, and they are being addressed through other avenues. We would request that the contractor share any knowledge he has or that he obtains

about the conditions of the window system with the City personnel in order to assist in planning any repairs to the windows.

A reminder: the plans were laid out to be printed on 11"x17" paper, not 24"x36" sheets as is common in construction. This was done for ease of carrying the plans into the field.

Let me re-emphasize:

Note to Bidders: Make sure that section 00201-1 is completely filled out and is placed on the outside of the bid envelope on the bid opening date. If that form is not on the outside of the bid envelope, the bid will not be opened.
