A) INVITATION TO BID:

- 1) Page 4; Additional Information – Change the second line on the second Paragraph to read:

“Keith at rkeith@cityoffoley.org no later than **96** hours....”

B) SPECIFICATIONS:

- 1) Page 5; Change Paragraph 1.09 to read:

#1.09 Additional Items of work by Contractor – see DWG-PAINTING-01 attached:”

- a) New flooring in Rooms “#104, #105, #106, #107, #108 & #109;
- b) Painting Rooms #102, #103 & #104;
- c) Moving Fire alarm outside of Room #113;
- d) Adjust and Add Fire Sprinklers as required.

NOTE: ROOM NUMBERS ON THE DRAWINGS ARE NOT THE ACTUAL NUMBERS ”

- 2) Page 7; Change Paragraph 1.1.1 item 21 & to read:

“21. Clean as required to keep dust & smell down with a thorough Final Cleaning @ completion.”

C) DRAWINGS:

- 1) Sheet A1:

- a) At bottom/middle of Floor Plan, change the leader stating “OWNER WILL MOVE...” to read “MOVE FIRE ALARM & ADD SPRINKLERS” – Alarm & Sprinkler work is by Contractor:
- b) Under ROOM NAMES change Rooms #102 & #103 to read:
“102 EXIST. OFFICE = NEW LIGHTS, FLOORING & PAINT WALLS
103 EXIST. OFFICE = NEW LIGHTS, FLOORING & PAINT WALLS”;
- c) ROOM FINISHES (upper right corner) – first line to read: FLOORING (SEE OWNER)
- d) Below the “ROOM FINISHES” remove the Note which reads: “*= TRY NOT TO DAMAGE FLOORING...IF DAMAGED, IT WILL BE REPLACED BY OWNER.”

- 2) Sheet A2: Note to right of MEETING ROOMS SOUTH ELEVATION to read:
"3/0 x 7/0 2" STYLE DOORS" in lieu of "3/0 x 6/8 2" STYLE DOORS".

D) PRICE SHEET:

The price sheet has been revised to list separate pricing for various aspects of the bid; however, the bid will be awarded based on the total cost of the project. Bids should be submitted using the price sheet provided in this addendum. Addendum acknowledgement is also found on this page.
