Utilizing electronic load tickets, computer tablets, and systems employing electronic contractor IDs with an Automated Debris Management System (ADMS) has become the industry standard and is critical for any successful debris operation in 2023. Because of the factors listed, we would like to confirm that any charges for the use of an ADMS will be included in the hourly rates provided and not as a separate hourly rate, other position, separate flat rate, or substitutional charge for any listed position.

Hourly rates should include any additional charges for ADMS. No additional line items for ADMS will be allowed.
