The utility plan provided in plan set, combined with the Palmetto Electric plans now attached, and the proposed routing map provide the best information for conduit locations, amounts and sizes at this time. Plan sheets are subject to change as final construction drawings are finalized. The successful bidder is responsible for installing the conduit and pull boxes in accordance with the plans and specifications. Building penetrations, poles, pulling of wire and data cable, and connections are the responsibility of others. The previous statement does not apply to the gates and associated equipment required to make the gates functional.

All prospective Respondents are reminded and hereby instructed not to contact any member of the Town of Bluffton Council, Town Manager or Town of Bluffton staff members, other than the noted contact person OR the Town's Purchasing Administrator regarding this solicitation or their response at any time during the solicitation and award process. Any such contact may be cause for rejection of your submittal.
