## ADDENDUM NO. TWO (2) – DATED JANUARY 26, 2021

The information given in this addendum is in addition to or supersedes conflicting information to the invitation to bid and is hereby made a part of the request.

**Question #1:** Is hardiboard and battens on the front only or front and both sides? Addendum 1 indicates front and sides? We assume we are to figure painting the hardiboard.

**Answer:** Hardie board shall be used on the front of the building only. This amends instructions given in Addendum 1 and is still supported by the Zoning Ordinance as clarified with the Orange Beach Community Development Department. Yes, the Hardie board shall be painted.

**Question #2:** If #1 is all hardi, how is this to be attached to the building? The original scope was to add a wall girt at 3'-8" above floor and then metal wall panels. If it is to be hardi should these walls be framed with metal studs, insulated, and then have a sheathing on the stud with Tyvek and then install the hardi board/batten? It would be difficult to attached the hardi on girts as there is nothing vertical to attach to.

**Answer:** Not applicable since Hardie board is to be used only on the front.

**Question #3:** Do the sky lights get replaced?

**Answer:** No, remove and roof over.

**Question #4:** Do the two ridge vents get reinstalled?

**Answer:** No, remove and cover with new roof. Provide sidewall fan exhaust for the building.

**<u>Question #5:</u>** Is there any electrical or HVAC that we are to figure when taking off roof?

**Answer:** Only for required exhaust fan. As an Add Alternate, please provide a price to provide a new HVAC unit for heating and cooling the front office space. Include removal of existing unit. The goal is to provide a system where exterior duct work is not needed at the exterior side/siding of the building. Provide a traditional unit with exterior condenser/compressor with interior air handler.

**Question #6:** Do we replace 10 or 20 purlins at the rear bays 1 & 2?

**Answer:** Contractor to field verify.

**Question #7:** The original specs called out to modify the columns at the bases and plates but Addendum 1 says to remove and replace both frame lines along 1 and 2. Keeping the existing columns and modifying the bottom few feet, new base plate, and new anchors would be adequate. Can you confirm which direction we are to take? Remove and replace entire columns and rafters at frame lines 1 and 2. Or just modify the columns and base plates?

**Answer:** Remove and replace. Base plate to have a minimum of four bolt hole locations.

**<u>Question #8:</u>** Replace existing window at North sidewall?

Answer: Yes.
