On 02-26-21, Dick Santistevan attended the above, mentioned Pre-Bid Conference (Friday 02-26-21, 10:30am at Rio Rico High School) and the following was discussed:

1.1 Introductions:

- 1.1.1 The Santa Cruz Valley Staff, ESD Representative and all other attendees introduced themselves.
- 1.1.2 Refer to attached meeting attendance sheet for all attendees.

1.2 "Housekeeping":

- 1.2.1 Included, IFB 21-08 Calendar of Events (plans available 02-19-21).
- 1.2.2 Bid Due Date (hand delivered on 03-05-21 by 10:00am at Santa Cruz Valley District Office, Attn.: Lourdes Ocampo).
- 1.2.3 Substitution Requests must be received via Email on 03-01-21 by 4:00pm.
- 1.2.4 Last date for questions 03-01-21 by 4:00pm.
- 1.2.5 The drawings and specifications are available via Link attached to IFB Exhibit A.

1.3 "Scope of Work":

- 1.3.1 Presented by Dick Santistevan and included the complete removal of existing fire alarm system (headend equipment, devices and cabling.
- 1.3.2 Replace with completely new Class 'B', Addressable, Voice Evacuation System type and required cabling.
- 1.3.3 "Fire Watch" is recommended for the duration of construction.
- 1.3.4 It is recommended that "Fire Watch" to be provided by contractor and included as part of bid.
- 1.3.5 Owner mentioned that there are plans for summer school.

1.4 "Discussion of School Classroom Availability"

1.4.1 Architect to address construction schedule with respect to SFB approval dates. There is concern regarding "Liquidated Damages" if project is delayed for any reason. The owner's preference is to complete project prior to start of 2021 school year.

1.5 "Questions and Answers":

- 1.5.1 Who performs the electrical contractor's scope of work?
 - 1.5.1.1 Fire Alarm contractor required to provide all sub-contractors including electrical contractor and any other applicable trades.
- 1.5.2 Is fire alarm system to be Class "A" or "B"?
 - 1.5.2.1 Fire alarm system confirmed to be Class "B".
- 1.5.3 What type of cabling required between NACPS control panels?
 - 1.5.3.1 Provide fiber optics network connections, not copper.
- 1.5.4 Is surge suppression protection required and FACP and NACPS control panels.
 - 1.5.4.1 Contractor to provide surge suppression devices at FACP and NACPS control panel locations.
- 1.5.5 Is "Third Party Certification" required at duct detector locations?
 - 1.5.5.1 Contractor to "Third Party Certification" at duct detector locations.

1.6 "Rio Rico High School Walk-Thru:

1.6.1 All attendees walked various portions of the existing high school campus.

Please include the following items as part of the next Addendum:

- 1.1 Contractor to provide "Fire Watch" services.
- 1.2 Contractor to provide all sub-contractors including electrical contractor and any other appropriate trades.
- 1.3 Contractor to provide fiber optic network cabling between FACP and required NACPS control panels.
- 1.4 Contractor to provide surge suppression protective devices at FACP and NACPS control panel locations.
- 1.5 Contractor to provide "Third Party Certification at duct detector locations.
- 1.6 Contractor to provide unit pricing including material/ labor and overhead for the following devices:
 - 1.6.1 Duct smoke detector including 75ft of open cabling.
 - 1.6.2 Duct smoke detector including 20ft of cabling in 3/4" red conduit.
 - 1.6.3 Ceiling smoke and/or heat detector including 75ft of open cabling.
 - 1.6.4 Ceiling smoke and/or heat detector including 20ft of cabling in 3/4" red conduit.
 - 1.6.5 Ceiling speaker/strobe including 75ft of open cabling.
 - 1.6.6 Ceiling speaker/strobe including 20ft of cabling in 3/4" red conduit.
- 1.7 On sheet FE2.2:
 - 1.7.1 At Main Gym, provide one (1) additional speaker/stroke device located on north wall above bleachers.
 - 1.7.2 At Main Gym, provide installation for (16) additional ceiling smoke detectors.
 - 1.7.3 At Secondary Gym, provide installation for (12) additional ceiling smoke detectors.
- 1.8 On sheet FE2.3, at Auditorium, audio by-pass upon fire alarm activation.
- 1.9 On sheet FE2.6, at Office C10, provide installation for (1) ceiling mounted speaker/strobe.
