**The following is an amendment to the IFB #290-17 2017 Dodge Vehicles:**


- 1 - The definition of Owner is the Commissioner of Roads and Revenue Dawson County, Dawson County Board of Commissioners, Dawsonville, GA.
- 2 - The Leer Camper rear window for each truck specified is to be equipped with tempered glass which is strengthened for durability.
- 3 - Please see the attached Revised Price Proposal following the questions and answers. A line has been added for a price for the 2017 Dodge Ram 1500 4x4 Tradesman, Quad Cab 6'4" box stating "price including Leer Camper". If you have submitted your bid package prior to the answer to questions deadline- please ensure that you have submitted separate pricing for this item with a Leer camper and without a Leer camper as requested in the specifications.

**The following are questions and answers to the IFB #290-17 2017 Dodge Vehicles:**

**Question:** Does Dawson County want the third row seat?

**Answer:** Yes, since there is not a cost savings to have it removed. As stated in the bid package, seats are to cloth and black in color. All other specifications for the seats are to be standard.

**Question:** Please clarify the attached information that is \*'d. We need more information for quote/bid to be completed.

**Answer:** The remaining portion of this particular specification as listed in the original IFB documents is as follows:

Camper Shell

The County wishes to receive pricing for the 2017 Ram 1500 Tradesman, 4x4, Quad Cab, 6'4" Box specifications with a matched basic camper shell and without a matched basic camper shell. The matched refers to the paint color to match the exterior body color.

**Question:** Durango – no 3<sup>rd</sup> row seating?

**Answer:** Yes, there should be 3<sup>rd</sup> row seating since there is not a cost savings to have it removed. As stated in the bid package, seats are to cloth and black in color, all other specifications for the seats are to be standard for both of the Dodge Durangos requested.

**Question:** All Dodge Truck – power windows?

**Answer:** All extended cab and crew cab vehicles come standard with power windows and door locks; all regular cab trucks come with manual windows. The IFB packages calls for standard specifications for each truck where special options are not specified.
