### **Question #1:**

Do you have any more information on site selection for either side?

We do not have any further information on site selection other than we will be hiring an agent for the week of February 15<sup>th</sup> to begin isolating some plots of land for consideration.

# **Question #2:**

Do we include geotechnical services in our proposals?

Yes, we do want geotechnical services included in the proposals.

# **Question #3:**

Do you have a construction budget for each project? In the May 2015 Facility Study recommendations the proposed 1700 student high school was budgeted at \$65 million with the middle school going into the former Central High school facility. Would this RFQ for a new middle school replace the idea of renovating Central High school into a middle school?

This RFQ does not replace renovating Central High School into a middle school.

# **Question #5:**
