# ADDENDUM NO. 1

Prospective Respondent,

This Addendum forms a part of the RFP Package Document dated October 20<sup>th</sup>, 2()21, with the amendments and additions noted below (deletions are shown by strikethiough and additions are underlined.)

Question: Scott Miller, the police is required for either event, in my opinion this is a nonstarter. If we are required to have police from the beginning of this contract if cwarded, either contract, I will not permit any alcohol sales whatsoever. Your permitting been sales may be why we are required to have police presence.

## Response: The police presence is mandatory, with or without alcohol sales.

Question: If we are the successful bidder on one or both of these contracts and ve have current merchants who have a current business license in the park, are they required to have a second business tax license at the new facility?

# Response: No, the business tax license is good for one year and can be used for both contracts.

Question: I am not sure if the trucks can sell beer on Sunday, I prefer not to allow any alcohol sales.

Response: There is NO alcohol sales at the Sunday Artisan Market. It is an option on Thursday nights for the Food Trucks. Question: Currently the parks department approves or not the merchants for the farmers market, will the currently approved merchants apply to the new market as well without reapplying?

#### Response: You will follow what the RFP states.

Question: Will our current business tax license be sufficient for the new market, if we are the successful bidder.

#### Response: Yes.

Question: Shannon Melendi Act – Does this apply to the merchants or food trucks or just management team.

## Response: This is just for the management team.

Question: In three weeks it will be dark at 5:30pm, will the Village be providing nighttime lighting for the Thursday night food truck contract.

Response: We are working with Public Service to get the streetlights working. Additional lights will be the responsibility of the organizer/promoter.

Question: Food trucks 75% Tents 25%, the tents can sell what products, food or thirngs other than food?

Response: Tents can only sell Food.
