Please be advised the following has changed:

1. CLARIFICATIONS & MISCELLANEOUS INFORMATION

- a. The general Contractor or subcontractor performing utility/sub-surface storm drainage work under this contract shall have an active Georgia Utility Contractor's License. The general Contractor is not required to have a Georgia Utility Contractor's license provided that his/her subcontractor performing the utility work does have an active Georgia Utility Contractor's License. If the general Contractor does not have an active Georgia Utility Contractor's License, the subcontractor's Georgia Utility Contractor's License number must be included on the front of the sealed envelope in which the Bidder submits his/her bid (in addition to the general Contractor's license number).
- b. Burning of removed/demolished/cleared vegetation is not allowed on site.
- c. The depth of the Class 3 rip-rap (to be placed between the handrail and existing wingwalls) shall be 18".
- d. The grade/cross-slope of the proposed sidewalk is shown correctly in the Typical Section on Sheet C2.0. This grade/cross-slope shall be 2% away from the road.

2. <u>TECHNICAL SPECIFICATIONS, SECTION 01025</u>

- a. Per Section 01025, the graded aggregate base to be constructed beneath the new sidewalk (both standard sidewalk and turn-down edge) shall be included in the sidewalk bid items.
- b. Per Sheet C1.0, the Contractor shall clear and grub all existing vegetation within the existing right-of-way. Payment for Vegetation Removal shall be as in Section 01025 Measurement & Payment.
- c. Costs for connection of existing storm pipe to new storm structures shall be included in the cost of the storm structure pay item.

3. CONSTRUCTION PLANS, SHEET C3.0

a. All new storm structures shall be precast structures in accordance with the construction details. A detail for the conversion/modification of existing catch basins to manholes has been included on the details sheet.

All bidders shall acknowledge receipt of all addenda issued where indicated on the bid sheets. (SECTION 00410 – Bid Form, Page 2)












TYPICAL SIDEWALK DETAIL




FULL-DEPTH ASPHALT DETAIL





CONCRETE SIDEWALK JOINT DETAIL






