REVISED

County Clerk and Trustees Office (Dickens Building), 728 Emory Valley Road, Oak Ridge, TN.

Demolition:

- Remove approximately 70 linear feet of block walls
- Remove approximately 4 foot long counter top
- Cut a 7' x 4' hole in block wall for customer counter space
- Move Fire Alarm and security lights

Flooring

- Lay approximately 1885 square feet of laminate flooring (Includes lobby and Clerk & Trustees areas)
– *flooring provided County*

Counters

- Furnish and Install approximately 11 linear feet of counter tops – *County will work with vendor on choosing counter tops*
- Furnish and install roll gate approximately 7 feet long – *approved equal to existing gate*

HVAC

- Replace the two (2) current wall units with two thru wall interior heating & cooling 110 units same or equivalent to Amanda or Mitsubishi.

DOORS:

- Install two (2) interior doors in main hallway use existing doors with new frame & hardware.

Drive Thru Window

- Changes to the drive thru window to block and remove drawer. Included in base bid price.
