**Addendum 01

Upgrades to Myrtle Manor Pump Station**

The purpose of this Addendum 01 to IFB 24-B0015 for Upgrades to Myrtle Manor Pump Station, dated October 19, 2023, is to list the key points of discussion from the mandatory pre-bid meeting, provide the Small Business Survey, and provide the sign-in sheet.

- This is a 180 day project from the issuance of the Notice to Proceed.
- Liquidated damages are \$500.00 per day.
- The prime Contractor is responsible for 70% of the work.
- Work times are between 7:00AM and 7:00PM, Monday through Saturday. No work shall be conducted on Sundays.
- The City shall inspect removed equipment and materials, at their discretion, to determine whether the removed items will be scrapped or salvaged.
- This project's location is outside of the City limits and is located within Horry County's jurisdiction. All permits and electrical inspections must be granted and approved through Horry County.
- Due to the surrounding restaurants and nursing home near the pump station, some debris or food grease may be present in the sewage lines.
- The awarded Contractor must coordinate with Santee Cooper regarding power poles that may obstruct the working area.
- The pre-bid sign-in sheet and Small Business Survey are attached and are hereby made a part of this addendum. The Small Business Survey is also attached
