Exterior Painting at Pepper Geddings**

The purpose of this Addendum 01 to IFB 20-B0007 for Exterior Painting at Pepper Geddings, dated July 12, 2019, is to list the key points of discussion from the mandatory pre-bid meeting.

- Elastomeric/EIFS was discussed as an option, but it will NOT be accepted as an alternate bid at this time. The existing price schedule remains unchanged.
- The building can be made available for Sunday work by making arrangements with the project manager in advance.
- The mural will not be painted.
- On the pool side of the building, the gutters/downspouts will not be painted. The windows will not need to be caulked.
- No fiberglass windows are to be painted. No light poles are to be painted.
- Rust spots will need to be corrected prior to painting. Metal gutters will have a high solid urethane finish. Aluminum will receive DTM paint.
- Contractor will be responsible for removing all insect nests prior to painting.
- The mandatory pre-bid sign-in sheet is attached and is hereby made part of this addendum.
- Bids are due in the Purchasing Office no later than 2:00PM (local time) on Wednesday, August 7, 2019. The City of Myrtle Beach is not responsible for late or misdirected mail. No e-mail submissions will be accepted.
