This addendum is being published to address the following item regarding the above referenced Request for Qualifications. This addendum becomes a part of the Contract Documents and modifies the original specifications and drawings as noted.

Item #1: Section 6.6 of the RFQ is hereby deleted in its entirety and replaced with the following:

6.6 Consultant shall indemnify, defend, save and hold harmless (collectively referred to as "indemnify" or "indemnification") the City, its employees, agents, and officers, of and from suits, claims, actions, damages, and expenses, including reasonable attorney fees, to the extent caused by the negligent acts, errors, omissions of the firm, and/or its agents, employees, officers, directors, consultants and subcontractors and suppliers ("Indemnified Claim"). An "Indemnified Claim" as used here and elsewhere in this Article 6.6 includes all claims, actions, suits, demands, damages, liabilities, obligations, losses, settlements, or judgments, as well as any expenses, including reasonable attorney fees arising from and to the extent caused by the negligent acts, errors, omissions, of the firm, and/or its agents, employees, officers, directors, consultants, subcontractors, and suppliers.

Consultant shall assume and take over the defense of the City in any such claim, demand, suit, or cause of action involving an Indemnified Claim upon written notice and demand for same by the City. Consultant will have the right to defend the City with counsel of its choice that is satisfactory to the City, and the City will provide reasonable cooperation in the defense as Consultant may request. Consultant will not consent to the entry of any judgment or enter into any settlement with respect to an Indemnified Claim without the prior written consent of the City, such consent not to be unreasonably withheld or delayed. The City shall have the right to participate in the defense against an Indemnified Claim with counsel of its choice at its own expense.

Consultant shall save, indemnify and hold City harmless and pay judgments that shall be rendered in any such actions, suits, claims or demands against the City with respect to any Indemnified Claim.

The indemnification and hold harmless provisions of this Agreement shall survive termination of the Agreement.
