Please see the changes below and include this signed addendum with your response.

DISREGARD THE BID AFFIDAVIT IN THE ORIGINAL BID PACKET. THE BID AFFIDAVIT ATTACHED TO THIS ADDENDUM IS REQUIRED TO BE RETURNED WITH YOUR BID

Due to changes in the area roadway designs, the main entrance to the Roy K Robb Facility will be on the south east corner of the property. Various changes to the scope of work are listed below:

Change length of fencing based on new site plan drawing. Contractor will verify dimensions.

Change from two sets twenty foot swing gates to one, thirty foot double swing gate set and one ten foot single swing gate set.

Change from two twenty foot cantilever slide gates to one thirty foot cantilever slide gate.

Delete the safety pipe rail fence.

Change the required gate opener if needed to accommodate the thirty foot slide gate.

Change Gate Pedestal to Dual Height Pedestal with two card swipe readers. The card swipe system is IEI brand with Hub Manager front end and was installed by Power Systems Security.

Delete Audio and Video Call station. Substitute the card swipe system as listed above.
