This addendum is being issued to revise the deadline for submittal of bids and answer questions received on this solicitation.

1. Submission Deadline, 4:00 p.m. Monday, September 11, 2023, via electronic submission.
2. RFI: Question Deadline, 5:00 p.m. Tuesday, September 5, 2023, via email.

Q1 Can the forms be filled electronically or are they required to be hand-filled scanned and then submitted?

A1 The official forms may be completed by typing or clearly printed by hand and submitted. The forms have not been set up as "fillable"

Q2 Can you please provide the incumbent contractor award amount (with a breakdown of a yearly cost) for both contracts?

A2 The response for FWQ 23-031: Caleus, LLC : \$115.50/weekly. Annual Spend Amount: \$6,006. \$150 for Emergency Cleans. The response for FWQ 23-036 Pressure Washing for multiple locations is being provided on an addendum posted for that specific solicitation.

Q3 Can the contracts be combined into one award amount if awarded both contracts?

A3 No, the solicitations FWQ 23-031 Cleaning and FWQ 23-036 Pressure Washing are for different types of services to be performed. Since some vendors do not offer/perform both services, we do not want to limit competition by combining them into one Solicitation.

- Q4 If Reverent Contracting LLC. is awarded 23-021 KSB and 23-036 CLG, can both contracts be combined into one award amount?
- A4 No. Each Solicitation would have its own contract tied to it. The Purchase Order would be the contract for each FWQ. Please note corrected FWQ 23-031 number**
- Q5 What are the scheduled cleaning hours for solicitation FWQ Number: 23-021-KSB?
- A5 The preferable schedule would be on Monday evening after 5pm, but may be subject to netotiation depending on need. Please note corrected FWQ 23-031 number.**
