This addendum is being issued to revise the bid documents to add additional requirements and to address questions received.

1. Bid Form (Section 00300) has been revised and changes are shown in underline format for those items added or quantities revised, specifically the following: Maintenance of Traffic, Construction Stakeouts and As Built Drawings, Testing and Pavement Markings. Bidders must use the attached Revised Bid Form when submitting a Bid.
2. Maintenance of Traffic (MOT) has been added to this project as a requirement. Please see Attachment A, Construction Plans SHEET 1 OF 6, for additional information that has been added.
3. Construction stakeouts and As Built Drawings will be required. Please see Attachment A, Construction Plans SHEET 1 OF 6, for additional information that has been added.
4. Testing has been added to this project as a requirement. Please see Attachment A, Construction Plans SHEET 1 OF 6 and SHEET 2 OF 6, for additional information that has been added.
5. Pavement marking quantities have been updated to match remaining of corridor. Please see Attachment A, Construction Plans SHEET 1 OF 6 and SHEET 6 OF 6, for additional information that has been changed.
6. Revise section 23.0 Request for Information (RFI) Deadline. The deadline to submit questions is **5:00 P.M. on Tuesday; May 7, 2019.**

Questions and Answers:

1. I did not see a line item for soils testing. Can you tell me what will be required? Will the subgrade testing be required to FDOT standards?

Answer: Please see Attachment A, SHEET 1 OF 6, for testing line item. Testing of subgrade, subbase, and asphalt is required. Yes, subgrade testing is required per FDOT Standard Specification from Roads and Bridges Construction 2019 manual. Please see Attachment A, SHEET 2 OF 6, for additional information that has been added.

2. Clarify where the joint line is in the asphalt? Provide a better graphic showing that line.

Answer: Please see Attachment A, SHEET 5 OF 6 and SHEET 6 OF 6, for additional information that has been added.

3. Signage being removed is going to the County?

Answer: Signage removed should be brought by the Contractor to County sign shop at Road and Bridge Facility where they will recycle.

2. Bidder has visited the Site and become familiar with and is satisfied as to the general, local, and Site conditions that may affect cost, progress, performance, and furnishing of the Work;
3. Bidder is familiar with and is satisfied as to all Laws and Regulations that may affect cost, progress, performance, and furnishing of the Work.

Bidder acknowledges that County and Project Manager do not assume responsibility for the accuracy or completeness of information and data shown or indicated in the Bidding Documents with respect to Underground Facilities at or contiguous to the Site. Bidder has obtained and carefully studied (or assumes responsibility for having done so) all such additional or supplementary examinations, investigations, explorations, tests, studies, and data concerning conditions (surface, subsurface, and Underground Facilities) at or contiguous to the Site or otherwise which may affect cost progress, performance or furnishing of the Work or which relate to any aspect of the means, methods, techniques, sequences, and procedures of construction to be employed by Bidder and safety precautions and programs incident thereto. Bidder does not consider that any additional examinations, investigations, explorations, tests, studies or data are necessary for the determination of this Bid for performance and furnishing of the Work in accordance with the times, price, and other terms and conditions of the Contract Documents.

This alternate requires the CONTRACTOR to use asphalt from the Highlands County owned asphalt plant for the construction of the project. The CONTRACTOR shall be responsible for retrieving the asphalt from the

asphalt plant and for placing the asphalt at contractor's cost. CONTRACTOR shall not be charged for the asphalt. The Highlands County asphalt plant is located at 12700 Arbuckle Creek Road, Sebring FL 33870.

Bidder agrees that the Work will be substantially complete within forty-five (45) days and completed and ready for final payment within sixty (60) days after the date when the Contract Times commence to run. The Contract Times will commence to run on the thirteenth (13th) day after the Effective Date of the Agreement or, if a Notice to Proceed is given, on the day indicated in the Notice to Proceed. A Notice to Proceed may be given at any time within thirty (30) days after the Effective Date of the Agreement.
- G. Bidder shall coordinate with the Project Manager in order to comply with all applicable quality control testing in accordance with the Drawings and Specification. Testing shall comply with the following governing standards and specifications: Florida Department of Transportation (herein after called "FDOT") Design Standards, latest edition, and FDOT Standard Specifications for Road and Bridge Construction, latest addition, as amended by Contract Documents.
- H. Awarded Bidder will be required to submit the concrete mix design. Before producing any concrete, the proposed mix design must be submitted to the Engineer. The Engineer may disqualify any concrete production facility for non-compliance with specification requirements of the Construction Documents.
