3.1 SCOPE OF WORK / MINIMUM SPECIFICATIONS AND SERVICE REOUIREMENTS (to include but not limited to):

Beaufort High School Auditorium

a) Replace damaged loft block idlers -We did not see evidence of any broken idlers.

Damage verified. Replace

b) Install new safety bolts. - Factory does not require safety bolts, but trim chain should be 1/4" instead of existing 3/16" chain

Install new

c) Install cable thimbles in all head block cable tie-offs. - These need to be addressed

On deficiency report

d) Replace all dead hung support chains - These need to be addressed

with proper size

e) Replace fire curtain safety chains - These need to be addressed

f) Install idler rollers in fire curtain rigging system - We were unable to identify "idler rollers" on the fire curtain system.

Confirmed in place and needing replacement

g) Install mounting clips on fire curtain head block – Clips appear present on existing fire curtain head block.

Replace clips with larger style having greater friction

h) Replace all malleable cable clamps with forged clamps. - These need to be addressed On deficiency report

- i) Replace lift cable on line-set #6 These need to be addressed
- j) Replace electronic fire curtain release system These need to be addressed

Beaufort High School PAC

a) Replace fire curtain release system. – Existing Fire curtain release system just needs to be adjusted

System has been professionally adjusted and will not maintain adjustment therefore replacement justified.

b) Replace fire line roller brackets. – Unable to identify "fire line roller brackets" on existing system

Replace existing brackets with heavier duty units and appropriate anchors

c) Install cable thimbles in all head block cable tie-offs – No tie offs were identified on existing system

d) Install mounting clips on fire curtain head block. – Clips appear present on existing fire curtain head block

Replace clips with larger style having greater friction

e) Replace all malleable cable clamps with forged clamps. – No Malleable clips were identified on current system

f) Replace fire curtain head block and hydraulic damper. – We could identify no issues with current system but will replace if requested.

g) Install cable management system for S/O cables. – Due to nature of existing SO cable layout, movable rigging is not suggested.

REVISED SCOPE

Hilton Head High School SCC

a) Raise bottom arbor stop to correct tension block issues

b) 02. Re-crimp all copper swage fittings

c) 03. Correct locking collar issues

d) 04. Install anti-sag bars to correct cable management issues

e) 05. Realign head blocks and loft blocks

f) 06. Replace bent arbor
