This addendum will amend <u>Bid #21-013, FY21 Municipal Lease/Purchase Financing For Vehicles &</u> <u>Heavy Equipment</u> originally issued on Wednesday, March 10, 2021. This clarification is being provided to all known and registered correspondents in response to questions received. All addenda and original Bid documents are also available online at: <u>www.gtcounty.org</u>, select "Bid Opportunities" from the Quick Links section and "View Current Bid Solicitations."

- **Question #1:** Page 4 requires a firm interest rate quote until closing but says closing will be no later than June 25, 2021 but in item 10 requires bids to be valid for a minimum of 30 days. If the bid interest rate needs to be held for 3 months it will be higher than for only 30 days. Also, page 15 Item 47 conflicts with the 30 day bid validity requirement.
- **Response:** The County is prepared to close once bid is awarded but no later than 6/25/21 and would expect the rates to remain valid until the closing date.
- **Question #2:** Page 4 states the County may or may not issue further debt that could impact the bank qualified status. Will this decision be made prior to funding this lease via an escrow account?
- **Response:** Yes, we will know by the closing of the lease agreement.
- **Question #3:** Page 6 item 18 does not allow contingent upon credit check. How can we obtain current audited and year-to-date financial statements to review?
- **Response:** Annual budget and financial documents can be viewed on the "Finance" section of the County webpage at <u>www.GeorgetownCountySC.org</u>.

- Question #4: Page 11 item 29 requires typewritten or ink bids only. However the IFB also says only electronic bids are accepted.
- **Response:** Due to COVID, we have changed our process from receiving in person bids to electronic bids through our Vendor Registry page only. However, this does not affect the language in item #29 on page 11 which still holds true. You would just be uploading your bid with all forms as a single pdf file under the bid on our vendor registry page.
- **Question #5:** Pages 11-13 have insurance requirements. As we are only providing financing out of state is this still a requirement?
- **Response:** A certificate of insurance would only be required if you were to come and perform work or services on County property. This would include if you needed to come for any training or consultant work. If not stepping foot on County property, then no, it would not be required.
- Question #6: Page 14 says invoices shall be paid within 30 days as does Page 32 section 3.1 and page 39 Exhibit B. Since this is a financing every day that passes adds accrued interest. Should our bid add 30 days of additional interest to our quote or will lease payment be made on the invoice due date?
- **Response:** All payments will be made annually by the due date.
- **Question #7:** Exhibit B has one item of collateral that is a boat. The bid asks for \$150,441 financing on a \$109,000 purchase. Why is this?
- **Response:** The formula in the spreadsheet did not get updated, the correct amount to be financed is \$109,000. See revised bid submittal form and revised Exhibit B attached.
