Contractors will be required to sign for receipt of the flash drive.

Any Contractor who wants a flash drive mailed to them must send a pre-paid UPS label to asowers@cityofmyrtlebeach.com to cover the cost of postage. Contractors choosing this option are encouraged to send their UPS label early to avoid delivery delays. The City of Myrtle Beach is not responsible for late or misdirected mail.

The historic main ID sign for the Fontainbleau Inn must remain untouched.
