CLARIFICATION OF QUESTION FROM POTENTIAL BIDDER

QUESTION FROM POTENTIAL BIDDER:

"Several clauses in the bid reference "quantities" and "schedule quantities" which are important to estimate when arriving at unit prices as single units will most normally be higher priced than larger quantities. We would appreciate an estimated usage of the product quantities as we discussed in order to provide the lower quantity discounted unit prices in our bid.

Since there is no anticipated site visit we appreciate your clarification that product deliveries will normally be made to the TPSB warehouse in Houma."

- Please see attached list of custodial chemical products ordered over the last 12 months.
- Please see the attached list of school and administrative sites that will need hand soap dispensers removed/installed.
- Please see attached requirements for insurance.
- After initial installation and removal of soap dispensers, all custodial chemicals shall be delivered to Terrebonne Parish School Board's Warehouse located at: 340 St. Charles Street Houma, LA.
- New and unused hand soap dispenser units shall be installed by the distributor on the wall at up to 46 schools and administration sites in the place of existing hand soap dispenser units and any additional locations deemed appropriate by the Terrebonne Parish School System.
- The distributor, while in the process of installing the new hand soap dispenser units, shall be required to remove the old hand soap dispenser units (regardless of manufacturer). The distributor shall be required to return the old hand soap dispenser units to the TPSB Warehouse for proper disposal by the Terrebonne Parish School System.
- The distributor, while in the process of installing the new hand soap dispenser units, shall be required to gather the old and/or obsolete hand soap (regardless of manufacturer) that went with the old hand soap dispenser units.
- The distributor shall be required to return the old and/or obsolete hand soap to the TPSB Warehouse for proper disposal by the Terrebonne Parish School System.
- Approximately 380 hand soap dispensers will be needed for the initial setup.

INSURANCE REQUIREMENTS FOR VENDORS, SERVICE CONTRACTORS, OR PROFESSIONAL SERVICES

The required insurance shall be approved by the Terrebonne Parish School Board before any site work may commence.

I. Workers Compensation

- A. Limit of Liability
 - 1. Coverage A Statutory requirements
 - 2. Coverage B \$ 500,000 Employer's liability
- B. Endorsements

 - 2. Waiver of Subrogation in favor of the Terrebonne Parish School Board

II. Comprehensive General Liability

IV. Other Requirements

- A. Suitable coverage may be required if special conditions or exposure exist. (i.e., Marine coverage, Property exposures)
- B. Current insurance certificate shall be on file with the Terrebonne Parish School Board and accepted by the Risk Manager.
- C. All policies are required to be on occurrence form basis, except those generally written <u>ONLY</u> on claims-made forms. (i.e., Professional, Errors & Omissions, etc).
