Addendum #01 RFP 24-R0012 December 15, 2023 Occupational Care Clinic Cleaning

The purpose of this Addendum #01 to RFP 24-R0012 for Occupational Care Clinic Cleaning dated December 5, 2023, is to list key points from the mandatory site visit and to provide the sign-in sheet.

- A door code, alarm code and key will be provided to the winning bidder with a clinic contact name and phone number.
- Please remember the Contractor shall remove from the job site all trash and debris associated with the work being performed and shall properly dispose of all waste. There are trash cans on-site that can be used. If the trash cans are not available, double bag the trash and place the trash in an out of the way location, near the back door and immediately call Val Rosser at 843-918-1007 to report the issue (leave voice mail if necessary). **Do not put trash in any dumpster.**
- There are four (4) employees that work in the clinic. All four (4) employees are not at work on the same days.
- There will be sign in sheet available for the cleaning crew to sign in for each cleaning.
- Additional questions are due no later December 27, 2023 at 2:00 pm local time. Questions must be submitted via email to jkobrien@cityofmyrtlebeach.com. Official time of receipt will be marked by the time the e-mail is received, and not the time that it is sent. E-mail messages can take up to ten (10) minutes or more to be delivered to the intended recipient. All questions received by the deadline will be answered via addendum.
- The sign-in sheet from the mandatory site visit is attached and is hereby made a part of this addendum.
