I. Questions & Answers

1. Will we receive a set of blueprints or will we have a chance to measure before submitting our bid?

No, not for the purposes of submitting a response to this solicitation, as it is for future as-needed services as projects arise. If awarded, the contractor will have the opportunity to measure projects prior to submitting a price.

2. Will there be an opportunity for an economic price adjustment?

Yes. Please refer to Appendix B General Services Price Agreement, Section 3G which reads:

Prices will remain fixed for six (6) months from the date of Price Agreement execution. Price adjustments & product changes will then be considered on a semi-annual basis. Price increase requests must be substantiated with demonstrated written evidence of cost increases to the vendor from the manufacturer. This measure is not intended to allow any increase in profit margin and is included only to compensate for actual market industry cost increases; vendors must submit a written request to the user agency or local public body for consideration.
