The City of Myrtle Beach reserves the right to refuse any goods and to cancel all or part of the goods not conforming to applicable specifications, drawings, samples, or descriptions. Acceptance of any part of this order shall not bind the City to accept further shipments nor deprive it of the right to return goods already accepted.

Risk of Loss: Delivery shall not be deemed to be complete until goods have been actually received and accepted by the City.

Warranty: Seller expressly warrants that the goods covered by this order shall constitute an agreement upon Seller's part to indemnify and hold the City harmless from liability, loss, damage, and expense, including reasonable counsel fees incurred or sustained by the City by reason of the failure of the goods to conform to such warranties. Such indemnity shall be in addition to any other remedies provided by law and consequential damages shall be limited as provided in Section 2-715(2) of the Uniform Commercial Code.


Entire Agreement: This contract contains the entire agreement of the parties. It may not be modified or terminated orally, and no claimed modification, termination, or waiver shall be binding on the City unless in writing signed by a duly authorized representative of the City. No modification or waiver shall be deemed effected by Seller's acknowledgement or confirmation containing other or different terms. All titles to clauses contained in this order are for identification only and shall not be construed as being as substantive part of the agreement.

Provision for the payment of the monies to fall due under this agreement has been made by appropriation, or by bonds, or notes duly authorized.

Separate invoices required for each purchase order and each shipment.

Rejected supplies will be returned at Seller's expense.

Unless otherwise noted terms of payment are Net 30 days.
