Sports and Security Lighting Electrical Service and Repair

The purpose of this Addendum 01 to IFB 21-B0021 for Sports and Security Lighting Electrical Service and Repair, dated March 4, 2021, is to list the key points of discussion from the mandatory pre-bid meeting.

- A copy of SC LLR Master Electrician certification and/or MASC Master Certified Electrician <u>must</u> be submitted with the bid documents.
- Any sports lighting that needs to be repaired/replaced will be with the same type of materials. No sports lighting poles will be replaced as part of this bid. If needed, a separate solicitation will be issued to replace sports lighting poles.
- Any security lighting that needs to be repaired/replaced will be with LED lamps as per the specifications in the bid documents. Security lighting poles can be replaced as part of this bid.
- Base year pricing will be calculated as the total of one (1) of each item on the price schedule. All pricing will be reviewed by a SC Master Electrician who works as part of City staff.
- Contractors are reminded to include their federal tax ID number on page 39 of the bid documents. In addition, contractors are encouraged to complete the local vendor preference form included in the bid documents if it applies to their business.
- Submit any additional questions to <u>asowers@cityofmyrtlebeach.com</u> no later than 12:00 noon (local time) on Friday, March 19, 2021. Any questions received will be answered in an addendum to follow. Until the time of award, no contact with other City personnel related to this project is permitted.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Monday, March 29, 2021. Late submissions will not be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail. No e-mail submissions will be accepted.
