QUESTIONS:

- 1. Would you also be able to send me a copy of the bid tabulation from the bid that opened March 4, 2022?**

- 2. When is the latest date & time addenda will be issued after the 1/20 @ 10am ET deadline?**

Answer: CCWA anticipates issuing the last addendum no later than 10:00 a.m. local time on Wednesday, January 25, 2023.

- 3. When is the earliest date we can mail our bid to make the 1/31 opening but have all addenda acknowledged?**

Answer: This is discretionary to the bidders. Bidders must arrange accordingly to have their bid packages delivered prior to bid opening on Tuesday, January 31, 2023 at 10:00 a.m. local time to our offices, located at 1600 Battle Creek Road, Morrow, GA 30260 – Attention: Procurement.

- 4. Mississippi Lime Co. has been the incumbent supplier Hydrated Lime Ca(OH)₂ to the Terry R Hicks WWP. I noticed in the recent bid request no line item for Hydrated Lime and just wanted to confirm if this material has been replaced or eliminated from your requirements. Can you please confirm?**

Answer: The Terry R. Hicks WPP just recently went through an upgraded and added a liquid lime system. This liquid lime system will take the place of the hydrated lime system and we will no longer have a need for Hydrated Lime.

- 5. Are you willing to consider bids that guarantee a supply contract, but contain language allowing for price changes within the course of the contract period at the three, six and/or nine-month point?**

Answer: The bid will be awarded for a 12-month period with no renewals and requires pricing to be firm during this time. Refer to the RFB documents on pricing.

- 6. I have tried to look for the bid tabulations from the 2022 Bid #2022-WP-07 on bidnet direct however I have not been able to find them. Could you send me a copy of these via email?**
