	Occupational license is not required to be issued in Indian River County and is typically issued in the municipality in which contractor is based.										
10.	Under the scope of work, it states the following:										
	• Trees, bushes, and shrubs need to be weeded, trimmed, and maintained. This includes tree branches hanging over the curb line and out in the travel lanes, dead tree limbs, the sprouts growing off the tree trunks. Please note that palm trees are NOT to be included for maintenance other than picking up palm fonds on the ground. Weeds need to be removed from plant and bush beds so that they are not growing out the sides or over the top of the plants.										
	It does not give how many times this has to be completed throughout the month or that standard of what the county is looking for. Was hoping for a bit more clarification.										
	The items listed under "General Requirements" should be completed during each cut.
