FENCING INSTALLATION, REMOVAL, AND REPAIR

This addendum is hereby incorporated into the Bid Documents for the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by underlining, deletions are indicated by strikethrough.

- 1. The bid opening has been changed from April 20, 2020 to April 27, 2020.
- 2. Q1: to Q8: are either clear on the Bid Schedule or were answered on Addendum 5. Also, Q20: through Q31: do not correspond to our Bid Schedule. The ITB Addendum 1 stated that all questions need to be received 10 days prior to bid opening (that would have been 4/10/2020), so I feel that this new addendum is out of scope per the ITB. Omit sections F, G and H from the Bid Schedule and move forward with the bid. Line numbers have been renumbered to be consecutive.
- 3. Questions and Answers:

Q1: Excel sheet All Bid Sheet Pg. 1 A-B. Chain Link. Line 15: NEED MORE INFO> Can you explain please?

A1: Line 15, deleted

Q2: 9 Gauge black vinyl is a residential (cost much less then 6 gauge) and 6 Gauge black vinyl is a commercial. So, are you wanting the 9 gauge on Black Vinyl or Galv?

A2: Addendum 6, everything on the bid schedule is 6 gauge.

Q3: Both 9 gauge in black and galv is cheaper the 6 gauge black. You would need your heights to be able to do a "price change for 9 gauge"

A3: Remove line 15a, everything bid is 6 gauge.

Q4: C. Gates No 5' or 6' wide gates (commercial mowers will not go through a 4' gate)?

A4: no change

Q5: There is nothing on here for Pool Code Hardware on gates?

A5: Added Line 23 on bid schedule

Q6: a) Line 24-28 20' wide would have to be double drive gates. b) D. Gates: Roll or Slide Line 29-38: These are all "Double Drive" not Roll/Slide Gates, does not use same hardware.

A6: a) moved to double drive section

Q7: A) Sheet E. Aluminum Fence: No Gates? B) Quote in Pressed Spears? C) You can not price Pressed spears same as finials, no where near the same cost. D) Line for added cost for Finials?

A7: added line 51

Q8: F. Barbed Wire Angled Top: Line 56-57: This is to go with Chain Link Fence? Move to section A-B for Chain Link?

A8: deleted section

Q9: G. PVC Line 65-68: No Width for specs (4', 5', 6', 10' DD, ect)?

A9: deleted section

Q10: Line 69: Green Vinyl top rail? Move to section A-B for chain link? THERE IS NO PRICE DIFFERENCE WITH BLACK AND GREEN VINYL.

A10: deleted

Q11: H. Timber & Trex fencing: Need more definition of Timber fencing. Trex is a composite material. If Timber is Pressure Treated wood you would need separate line items for pricing. They are not comparable at all in pricing.

A11: deleted section

Q12: N. This section is for Chain Link? Move to section for Chain Link?

A12: aligned numbering to bid spec

Q13: M. Baseball/Softball Backstop: & N Tennis Court Line 108: WIRE ONLY? Or post for backstop to be included with this? PLEASE BE MORE SPECIFIC. There are NO post long enough on this bid sheet for back stop post.

A13: defined bid schedule as wire only. Added lines under posts for 15, 16, 18, & 20 feet. Added middle rail, 15' for tennis courts section.

Q14: Line 110: Define Framework please. Does this include your Post?

A14: Entire structure

Q15: Line 111: Install of Wire ONLY? Or post to be included with this? see highlighted N line

A15; wire only, posts have been added as a separate line item under posts.

Q16: Line between 113 & 114. PLEASE BE MORE SPECIFIC. No post long enough on this bid sheet for tennis court TERMINAL OR LINE POST.

A16: posts have been added to the bid schedule.

Q17: Line 113: Define Framework please. Does this include your Post?

A17: It states wire, so wire only

Q18: Line 114-119: Can you please specify what you mean by the 3', 4', 5', 6', 8' & 10' Middle Rail? Middle rail should just be middle rail. No height and width on this.

A18: middle rail removed in tennis court section, as top, middle, and bottom rail are included in section A-B.

Q19: Line 36 & 37 Needs a line for 4' & 6' high, corner and end post.

A19: corner & end posts are already specified in section I.

Q20: Line 73-141: 9 gauge black is residential and city of Daytona does not use this, they use 6 gauge commercial.

A20: all items bid will be 6 gauge. ??? only have 125 lines

Q21: Line 203: need separate line item for Field Fencing with Barbwire and 4 strand Barbwire. Also need separate line item for Pull/End post brace; Corner post brace; In-Line post braces.

A21: ??? only have 125 lines

Q22: HC Galv fence wire installed. Labor & Material Line 1-4: WIRE ONLY? Include line post ? Top/bottom Tension wire?

A22: see #2

Q23: Line 5-8 Include line post? Loop Caps? Bottom Tension Wire?

A23: see #2

Q24: Line 9-38: You have no 2 ½" End/Corner/Pull post as specified in written specs 2.3 5. Vinyl Coated fencing installed. Labor & Material?

A24: see #2

Q25: 105-108: 6 Gauge black vinyl? Line Post included?

A25: everything bid is 6 gauge. Yes, line posts included.

Q26: Line 109-132: You have no 2 ½" End/Corner/Pull post as specified in written

specs 2.3 5. Legends Vinyl 6' Privacy Fence.

A26: ??? only have 125 lines

Q27: Line 225: Legend only has 6'Hx4'W or 6'H x 5'W, they do not carry a 6'Hx6'W.

A27: ??? only have 125 lines

Q28: Line 226 Legend only has a 6'Hx10'W DD gate, they do not carry a 6'Hx12'W.

A28: ??? only have 125 lines

Q29: Line 227: explain please Montage Plus Ornamental: THIS IS STEEL, NOT

ALUMINUM. Is that what you are wanting? Steel?

A29: ??? only have 125 lines

Q30: Line 239, 243: PLEASE EXPLAIN

A30: ??? only have 125 lines

Q31: Line 244: Specify please. 2 rail, 3 rail or 4 rail? Or is the Split Rail?

A31: ??? only have 125 lines
