The purpose of this Addendum 01 to RFP 22-R0007 for Court Resurfacing at Midway Park, dated August 5, 2021, is to list the key points of discussion from the mandatory pre-proposal site visit.

- The City will remove all basketball goals and tennis nets. The City will also be responsible for filling in holes and setting poles.
- Offeror is to fill all cracks that can be seen. Offeror is repairing cracks only, not chips.
- Offerors are responsible for their own measurements. Any measurements given in the proposal document are best estimates.
- Lines on the basketball court will be repainted according to their current dimensions.
- Offerors are reminded that additional materials (other than price) must be submitted with their proposal for evaluation. Factors such as company overview, past performance, and statement of work, in addition to price, will be used to make award determination. Offerors are strongly encouraged to review the entire proposal document to ensure that they submit everything that is required.
- Additional questions are due no later than 12:00 noon (local time) on Tuesday, August 24, 2021. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com. All questions received by the deadline will be answered via addendum.


